What Are Your Pronouns?!

Ask people the pronouns they use for themselves whenever you ask people their name, such as when you meet someone for the first time or when you do go-arounds at meetings Keep in mind that people may change the pronouns they go by, so it is necessary to ask pronouns in go-arounds regularly Don't!
