By definition, a "Surplus Lines agent" is an individual licensed to handle the placement of insurance coverages with unauthorized issuers, and to place such coverages with authorized insurers as to which the licensee is not licensed as an agent.

Be licensed as a Florida resident general lines insurance agent (2-20). Step 2 - Must have the following prerequisite(s) before applying: Successfully completed a 60-hour approved insurance course in surplus and excess lines insurance. Must be completed within four years of application date.
