APA recommends that your title be focused and succinct and that it should not contain abbreviations or words that serve no purpose. Your title may take up one or two lines. All text on the title page, and throughout your paper, should be double-spaced. Beneath the title, type the author's name: first name, middle initial(s), and last name.

In APA style, the in-text citation for a psalm includes more specific information about the reference, so you do not include the Bible on your references page. Instead of a page number, the parenthetical citation lists the book, chapter and verse with a colon between the chapter and verse.

Provide the author of the whole book in the main author element of the reference. Then provide the name of the person who wrote the foreword, introduction, or other new part, in parentheses, after the word "with." In the example, Byock wrote a new foreword to the book by Kübler-Ross.

In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).
